

Code of Conduct for Students

Banda University of Agriculture and Technology, Banda (U.P.) has developed a code of conduct to ensure that students follow the norms and guidelines set forth by the university. This will help the university to preserve harmony and develop a comprehensive educational environment. Therefore, it is required that all students must be aware and follow the set code of conduct during their degree programs.

Jurisdiction

The University shall have the authority over the conduct of the students enrolled with the University. They have to be aware of all inappropriate conduct, which occurs on campus or off campus during University-related activities.

The University may also exercise authority over behavior that occurs off campus that violates the standards for discipline and good student behavior set forth in this policy handbook and other applicable regulations, as if the conduct has occurred which shall include.

- Any violations of the Sexual Harassment Act-2013, GoI will lead to 1. disciplinary action as per the University Sexual Harassment Policy.
- Physical assault, threats of violence or conduct that threatens the 2. physical and mental health or safety of any person including other students.
- Possession or use of weapons, explosives or destructive devises on 3. campus or off-campus.
- Manufacture, sale or distribution, promotion and consumption of 4. prohibited drugs, alcohol and other intoxicants etc.
- During their stay at the university, all students should carry ID with them 5. at all times.

- 6. On and off the university campus, students are required to uphold the highest levels of standards and discipline.
- 7. Students are expected to follow all university policies and guidelines in order to uphold the university's reputation.
- 8. All of the students are required to be present in class at the designated time.
- 9. In case of extenuating circumstance a student may be permitted to leave the campus with due permission from Advisor or the Authorities of the concerned college. The authenticity of the reason for such permission will be validated from parents/guardian.
- 10. Students should strictly adhere to the decent dress code in university premises.
- 11. All requests for leaves or any other issues must be submitted through proper channel to the concerned authority.
- 12. Any conduct that violates accepted social norms, will lead to disciplinary action.
- 13. Conduct which has a negative impact or constitutes a nuisance to the surrounding.
- 14. All the students must take prior permission for keeping vehicles in the hostels.
- 15. All students driving in university campus are abiding to follow "The Uttar Pradesh Motor Vehicle Rules, 1998".
- 16. Driving rashly is prohibited on campus. Horn sounds that are excessively loud and have a negative environmental impact are not allowed on campus.
- 17. In University, students are expected to behave properly. Any improper behavior, including hooting, whistling and loitering will be viewed as a sign of indiscipline.
- 18. Students are advised to use the classroom, library, or other designated areas of the academic building during independent study hours and refrain from sitting on stairwells or other areas where they could hinder movement.
- 19. Students are being encouraged to use mobile phones/ internet content/ social media networks mainly for academic and research purposes aligned with Information Technology (Amendments) Act, 2008.
- 20. The right place should be used to dispose of waste. As the students have responsibility to keep the campus neat and clean, it is their duty to act accordingly.

- 21. It is highly forbidden to consume any type of substances that intoxicate or psychotropic substances, drinking, smoking or using tobacco products etc.
- 22. Students are being refrained from doing anything such as writing or throwing rubbish on the walls, doors, or any furniture as such could deface the university and disrupt the academic environment.
- 23. During class and lab hours, take the appropriate safety precautions.
- 24. Students are responsible for covering the cost of repairs or replacement for any damage to hostel/university property as well as paying a fine.
- 25. Without the consent of the competent authority, students are not permitted to distribute or display any leaflets, notifications, brochures, or banners on campus.
- 26. Students are expected to attend various competitions, special programmes and events organised at the University for their Holistic Development.
- 27. Students who wish to represent the university in intercollegiate competitions must obtain prior approval from the pertinent department head, and the criteria for selection will be set by that department.
- 28. Students should not participate in any unauthorized meetings, the dissemination of propaganda, processions, and the collection of funds in hostels and outside of campus locations.
- 29. All students are warned that Ragging is illegal and is punishable by "Prohibition and Eradication of Ragging Act, 2019". Strongest actions will be taken on found engaged in such activities.
- 30. Physical or psychological harassment of female students as well as misconduct involving threats or acts of violence against faculty, staff, or other students will be dealt with in accordance with the law.
- 31. Without prior consent from the authority of the university, students are not permitted to speak with or invite media personnel on campus in the name of the university.
- 32. It is not permissible for students to record other students', faculty members', or staff members' actions in class or during lectures without authorization.
- 33. Without prior authorization, students are not allowed to give media any audio or video clips of any activity taking place on campus.
- 34. Students are restricted from distributing any disparaging remarks regarding academic staff, fellow students, or the university on any website or social media platform.
